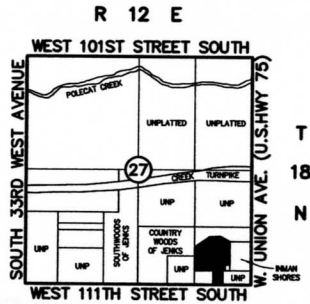

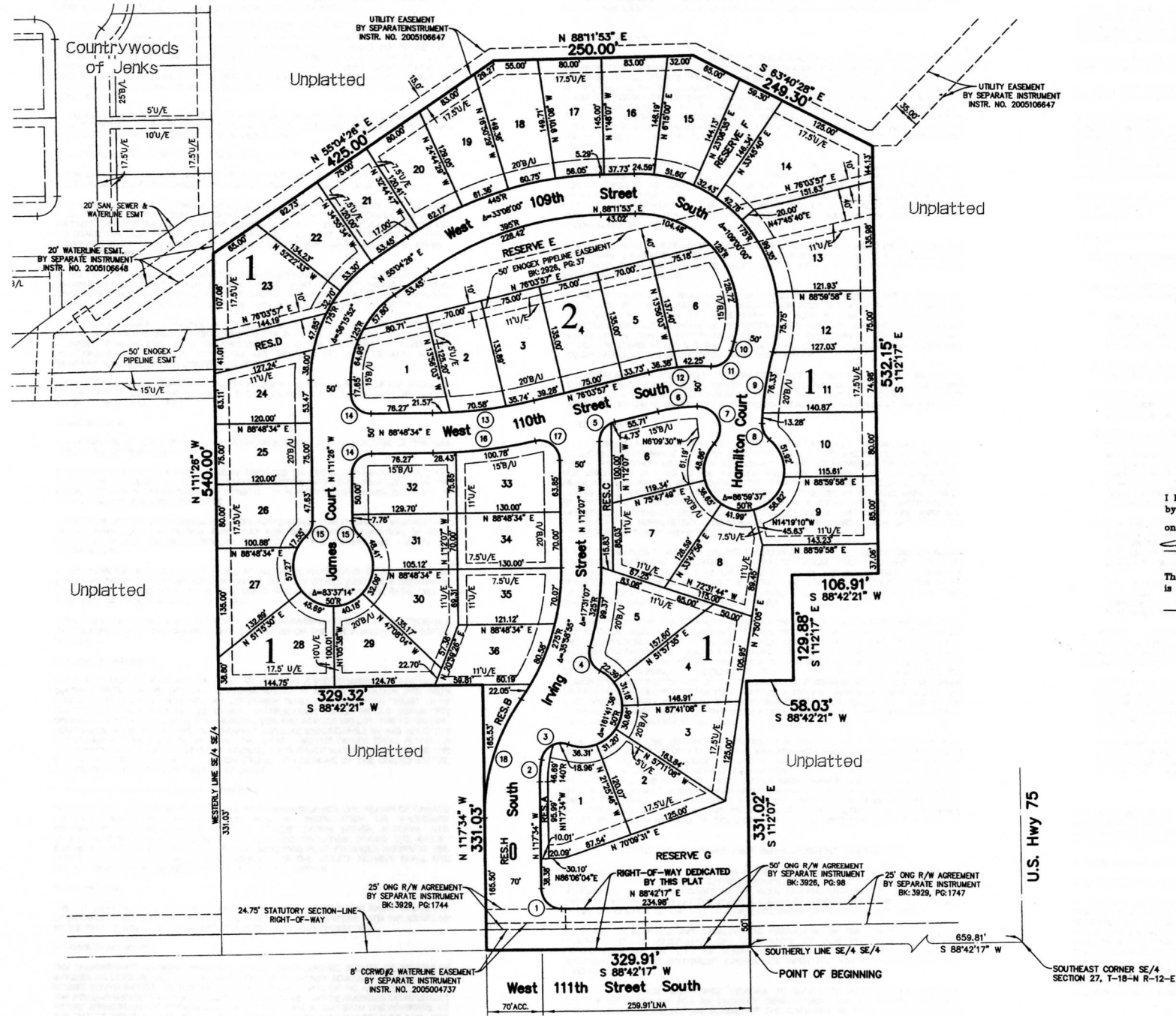
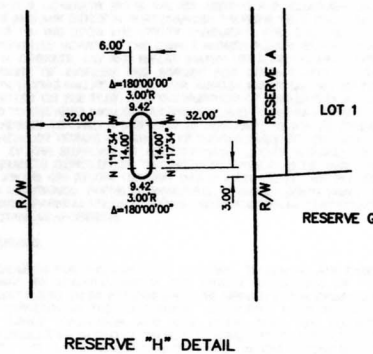
Location Map
